- 10. <u>Data Protection</u> The Clerk is going to attend a meeting regarding the new legal requirements.
- 11. <u>District Councillor's Report</u> Our new Councillor has been in post for two months now; she has met the Directors of Departments, had cards delivered through the doors of her parishes and inserted a column in the Frome Valley News.

Section 106 payments go into community benefits when eleven or more houses are built.

She has a special interest in the hospital and social care; all positions are filled at present, but she will attend meetings.

She has met Clive Hall to discuss the A4103 which failed the community recently when part of it was resurfaced, causing a lot of concern.

A council tax rise, was voted through by a large majority, which she was not happy to vote for.

The county farms were sold for 42 million; this money will be invested in land to ensure there is more control over where and what is built; the builder splits the profit. The danger could be that too many are built, too quickly. It is important that the plans are scrutinised.

There is an older demographic in the County.

Stoney Cross, Cradley, is an accident blackspot, but will receive attention soon. There will be traffic lights with a convoy system, while the work is going on.

Consultation will take place on the proposed by-pass. It should cost around £150 million, but may not alleviate the traffic- 6,000 new houses are going to be built creating a lot more traffic.

She has visited Cradley Primary School.

The new Locality Steward, Paul Hunter, Balfour Beatty starts in March. The Council has got money back from Amey who they took to Court. There is extra money for potholes.
